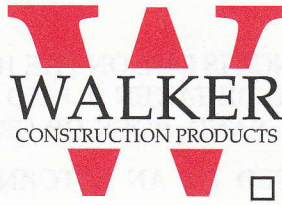

REPRESENTATIONS AND WARRANTIES

The undersigned represents and warrants that he/she is duly authorized to execute this credit application. The undersigned understands that the information provided herein is to induce W/C and WCP to extend or to continue the extension of credit. The undersigned acknowledges and understands that W/C and WCP are relying on the information provided herein in deciding to grant or to continue credit or to accept the guarantee provided below. The undersigned represents, warrants and certifies that the information provided herein is true, correct and complete. The undersigned agrees to notify W/C and WCP immediately and in writing of any changes in names, address or legal entity and of any material adverse change (1) in any of the information contained in this application or (2) in the financial condition of the company seeking credit. W/C and WCP are authorized to make all inquiries they deem necessary to verify the accuracy of the information contained herein, and to determine the credit worthiness of the undersigned. W/C and WCP are authorized to answer questions about its credit experience with the company seeking credit.

The undersigned further represents and binds the company seeking credit to W/C and WCP's standard terms and conditions, which may change from time to time, to each and every transaction, unless specifically agreed in writing otherwise.

Any controversy, dispute, or claim that Buyer may have against Seller must be initiated no later than one (1) year after the Materials were delivered.

Applicant agrees to hold in trust all funds paid to Applicant for goods and services provided by W/C and/or WCP and to promptly pay W/C and/or WCP that portion of such funds owed by Applicant to W/C and/or WCP for same in accordance with O.C.G.A. § 13-11-4. Applicant acknowledges that it has a fiduciary duty to W/C and/or WCP to faithfully account for all funds paid to the Applicant for goods and services provided to the Applicant by W/C and/or WCP. The undersigned executes the within and foregoing document in his/her individual capacity so as to be personally bound hereby and on behalf of Applicant.

PERSONAL GUARANTEES

For valuable consideration received, and to induce W/C and WCP to extend credit to the company seeking credit, the undersigned, jointly and severally guarantee and promise to pay any and all indebtedness of the Applicant seeking credit and they each severally agree to pay all costs of collecting or securing or attempting to collect or secure under this personal guarantee, including reasonable attorney's fees, whether the same be collected or secured by, or any attorney consulted with reference to, suit or otherwise. This is a continuing guarantee relating to any indebtedness including that arising under successive transactions. W/C and WCP have the authority to extend the time of payment of any indebtedness hereby guaranteed and to renew, modify or accelerate the terms or provisions of the indebtedness or any part thereof, without notice and without releasing the liability of the undersigned. The undersigned waives any rights to W/C and WCP to give notice of indebtedness or default of payment. Nor will it be necessary for W/C and WCP to procure a judgement against the company seeking credit before demanding the payment which is hereby guaranteed. This guarantee shall be continuing, absolute and unconditional and shall remain in full force and effect as to the undersigned and his/her estate. Execution is notice to the undersigned of his/her acceptance and no further notice of acceptance is required.

Further, the undersigned agrees that W/C and/or WCP may modify or withdraw, at any time the terms of credit extended to Applicant. The undersigned waive presentment, demand, notice of dishonor, protest and all other notices whatsoever and agrees, that W/C and/or WCP may enforce this guaranty without first or contemporaneously or otherwise seeking or proceeding to collect from Applicant.

JURISDICTION AND VENUE

The undersigned, including applicant and any and all Guarantors, acknowledge W/C and/or WCP is a Georgia corporation having a corporate office and principal place of business in Fayette County and agree that the Superior Court of Fayette County, Georgia is a court having subject matter jurisdiction over any dispute regarding labor or materials provided by W/C and/or WCP to Applicant and that such Court is the most convenient forum and venue in which to bring any legal action arising out of or in connection with the labor and materials provided by W/C and/or WCP to Applicant, including payment to W/C and/or WCP by Applicant.

The undersigned, including Applicant and any and all Guarantors, waive personal service of process of any civil action commenced in the Superior Court of Fayette County, Georgia (or any other Court having subject matter jurisdiction) against Applicant or Guarantor(s) for collection of Applicant's account as authorized in this Credit Application and consent that service of process may be made by statutory overnight delivery or by certified U.S. mail to the address provided by Applicant in this Credit Application or at any other address submitted by Applicant to W/C and/or WCP.

INTEREST AND COLLECTION

Any payment not made when due shall be subject to a charge of one and one-half percent (1-1/2%) finance charge per month or the highest allowed finance charge, whichever is less, on the unpaid balance. Buyer shall pay all costs and expenses incurred in collecting sums due or owing, including court or arbitration fees and costs, attorneys' fees, and expert witness fees, arising before, during, or after trial, including any costs, attorneys' fees, or expenses incurred in any appeal there from.
